DEPOSITS: Seller will hold a puppy on the seller’s premises no longer than 10 weeks after birth and an adult dog no longer than 3 weeks from the date of this contract; in exchange for a deposit of \$500.00. This deposit is non-refundable unless the dog becomes ill and cannot be sold.

AMOUNT OWED \$2,450, which is due upon pick up if you are personally picking up the Dog. If you are shipping the Dog then the Amount Owed is due 5 days prior to shipping. The Seller only accepts electronic fund transfers, certified funds, and or cash.

HEALTH GUARANTEE: The dog will be up to date on shots, dewormed, microchipped, has had dewclaws removed, and if there were any hernias or pinched nostrils they were fixed by our vet before the puppy is picked up. If the Dog at a later date is found to have a terminal genetic defect that is confirmed as terminal by a licensed veterinarian, the Seller will replace the Dog with a similar dog of equal value within 2 years of the diagnosed date.

REGISTRATION PAPERS: The Dog is registered with the AKC, and unless otherwise noted in this agreement. The Dog does not come with breeding rights to register any future litters of this Dog unless otherwise noted in this agreement.

In order to receive the AKC registration papers for any female you must provide proof of being spayed within 8 months of the date written on this contract.

If for some reason a male puppy could not be neutered at his 8 week vet appointment the Buyer will be required to show proof of neutering within 8 months, of the date written on this contract, to receive the Dog's AKC registration papers.

Once we have received an accurate document, from your licensed veterinarian, stating that your dog has been spayed (or neutered) in order to receive the Dog's AKC registration papers Via Mail within 60 days.

If your male puppy was neutered by us, you will receive AKC papers upon the day of pickup.

ADDITIONAL PROVISIONS:

- Seller agrees to provide the original health papers.
- Buyer agrees that if there are any legal action is to be taken regarding this agreement the case will be under the jurisdiction of the circuit court in Benton County, Missouri
- When Buyer and Seller sign this contract, it will then be binding on both parties.

GOVERNING LAW: This Bill of Sale shall be governed by and construed in accordance with the laws of the State of Missouri. Should any clause be in conflict with the Laws of Missouri, that clause shall be null and void.
